- 1. Consent Agenda Any item will be removed from the consent agenda at the request of any member of the Board and that item will be considered separately later.

ACTION: Approve the consent agenda or take such action deemed appropriate.

Scott moved and Sullivan seconded approval of the consent agenda. Motion carried unanimously.

2. Public Comment for items *not on agenda*: 3 minute limit – Vaughan thanked Jones for giving him a tour of both of the urban renewal districts. He said it was very informative and he appreciated it very much.

3. Announcements

- o New Budget Year Jones said the new budget year starts in October and budget books have been distributed.
- o Redevelopment Association of Idaho Jones said he attended the annual Redevelopment Association of Idaho meeting last week and he gave the officers names. He said a legislative committee has been formed. He said it sounds like there may be bills already drafted. He discussed the dues and said the cost will be \$500 if the Moscow URA chooses to remain a member. He displayed a list of members in the organization.
- Public Information Request Idaho Freedom Foundation Jones briefed the Board on the items that
 were sent to the Idaho Freedom Foundation in response to this public information request. Jones
 answered questions about the Idaho Freedom Foundation.

o EPA Brownfield Coalition Grant Public Kickoff Event at City Hall, October 6th, 5:00 – 7:00 p.m. – Jones distributed a flyer for the EPA Brownfield Coalition Grant Public Kickoff Event. He said it is good for anyone interested in buying or selling property to take advantage of this opportunity. He asked for assistance in circulating the flyer. Scott asked if this will be used at the Dumas Seed site. Jones said that site was identified in the application but the owner needs to make the request. He explained the process. He said the consultants will be at the kickoff event to answer questions and make notes about who is interested in participating in the program.

4. Legacy Crossing Urban Renewal District Status – Jeff Jones

- O Sack Warehouse Demolition Jeff Jones
 Jones said the Sack Warehouse Demolition has been completed and the contractor will supply a plot
 plan. He will cut a check for \$32,500 when he receives the plan. Palmer said he did some forecasting
 and it looks like the 2012 budget is on track. There was discussion about a slightly damaged power
 pole that needs to be relocated. Jones explained that the contractor has taken care of the costs for
 the structure that was mistakenly demolished. He discussed what will be done with the property
 while it sits. He said the next thing is to get bids on asbestos removal on the small building. It will be
 \$4,000 to take the building down after the asbestos removal is done. An ALTA survey will need to be
 done on the property. Lamar asked if everything can be completed before winter. Jones said he
 thinks that the demolition can be done but he is not sure about the survey. He will come back to the
 Board after bids have been solidified. Riedner asked if anything will be done with the sidewalk this
 year. Jones said the sidewalk is a City function and the tree roots are a problem. A survey needs to be
 done to find out where the right-of-way is prior to a sidewalk being installed. Riedner discussed other
 projects happening in the area. Jones said he has already been approached by an investment group
 about this property. He discussed the Hello Walk.
- o Anderson Group, LLC Owner Participation Agreement Jones said the Anderson Agreement was executed last week and the first reimbursement check was issued for \$511.00.
- 5. Alturas Technology Park Status Jeff Jones

Jones said there has not been much change to Alturas but it is nice to have the road fixed. He said Alturas is a great accomplishment for a city this size. He indicated that the USDA Natural Resource Conservation Service and Farm Service Agency will be in the new building on Indian Hills Drive. He has met with one of the Alturas businesses interested in expanding and he is assisting with that process to allow them to meet the restriction of not having a building footprint be more than 25% of the property.
