4. Legacy Crossing Urban Renewal District Survey Services RFP – Jeff Jones

**ACTION:** Approve selection of Rim Rock Consulting, Inc. for On-Call General Land Surveying Services and authorize the Executive Director to execute a "not-to-exceed" contract between the MURA and Rim Rock Consulting, Inc. in the amount of \$12,000 for on-call general surveying services that are to be completed on a Task Order basis or take such other action deemed appropriate.

Jones said staff advertised an RFP for survey services. He said he met with McGraw and McCabe to go through the proposals. Rim Rock Consulting rated slightly higher. He explained what staff is requesting. Scott moved to approve selection of Rim Rock Consulting, Inc. for On-Call General Land Surveying Services and authorize the Executive Director to execute a "not-to-exceed" contract between the MURA and Rim Rock Consulting, Inc. in the amount of \$12,000 for on-call general surveying services that are to be completed on a Task Order basis. McGeehan seconded the motion. Scott asked if the Agency will be able to pay for this contract. Jones said if money is cut from the budget, it will not be from this area. There was discussion about the details of the contract and the sites where it might be used. Brown asked how many sites could be surveyed. Jones said it depends on what type of survey will be done and he gave some examples. He discussed the process that was used. There was discussion about who would be responsible to pay for a survey. Jones explained what information the Agency will get from the survey on its property. Motion carried unanimously.
