3. Public Hearing: Proposed Amendment to FY 2021 Agency Budget (A) – Bill Belknap

The Agency has either closed on, or will close on, the sale of 5 lots within Alturas Technology Park which was not anticipated when the FY2021 budget was adopted. In accordance with State Law, the Agency is required to conduct a public hearing to amend the adopted FY2021 Budget to receive these additional revenues that were previously unanticipated. In accordance with prior Board direction, once the Agency has received the funds from the two lots currently pending closing, the Agency will disburse the net proceeds to the Latah County Treasurer for distribution to the taxing districts.

ACTION: After considering public testimony, approve the FY2021 Budget amendment and the corresponding Resolution 2021-03; or take such other action as deemed appropriate.

4. Alturas Lot Sale Request for Bids Results (A) – Bill Belknap

On July 17th, the Agency published a request for bids for the Agency's remaining three lots within Phase II of the Alturas Technology Park. Two bids were received that met the minimum bid price, therefore two of the three remaining lots are now advancing to closing. The agency will be left with one remaining lot (Lot 2 of Block 2) which has some grade challenges that will likely result in increased development cost. Staff is recommending that the Agency publish a new request for bids for the last remaining lot and lower the minimum bid price for Lot 2, Block 2 by twenty-five percent to increase the likelihood of the sale of that lot.

ACTION: Review the proposal and provide staff with direction as deemed appropriate.

Sullivan called the meeting to order at 7:02 a.m.

3. Public Hearing: Proposed FY 2022 Agency Budget - Bill Belknap

Staff has prepared the draft FY2022 budget document which includes anticipated Agency revenues and expenditures for the upcoming FY2022 fiscal year. The draft budget was reviewed the Agency Board on June 3, 2021 and recommended forwarding the budget to public hearing. In accordance with State Law, the Agency is required to conduct a public hearing upon the annual appropriations budget to allow for public comment and testimony.

Belknap presented the proposed budget as described above, recommending approval with no changes after public comment and testimony. Payment to Latah County for FY2022 will be adjusted from \$6,500 to \$5,000, per the repayment schedule. The sale of the Sixth and Jackson property is projected to close before the end of FY2021, but the revenue from the sale is calculated in the FY2022 budget because of how close the closing will occur to the end of the year.

Public Hearing opened at 7:20 AM

Victoria Seever, Moscow, talked about the Urban Renewal Agency's participation in upgrading the downtown streetscapes in regards to the entertainment district that is developing. Moscow's assets are being highlighted by the current development projects. Gave praise for keeping a balanced budget and spending funds in a responsible way.

Public Hearing closed at 7:23 PM

Board members discussed the fiscal responsibility shown by the draft budget and agreed to keep it conservative and well-rounded. There was some talk about upcoming projects in FY2022 in regards to the proposed spending plan. The administrative costs are significantly lower than what they used to be; \$80,000, annually, down to approximately \$50,000 after streamlining the position and services of the Executive Director, Clerk, and Treasurer.

Bettge moved for approval of the Fy2022 Budget and corresponding Resolution 2021-02 as presented, seconded by Tribble. Motion carried unanimously.

4. General Agency Updates

• Legacy Crossing District

The DDA for the Sixth and Jackson property currently being developed. Appraisal has concluded and the information gained will be used to set a sale price. There was some discussion about the URA's work on this development project over the years.

• Alturas District

Another Request for Bids advertisement was published. All the lots that were previously bid on have closed sale. Two parties have communicated interest in two of the remaining lots.

This year, we are recommending a change totaling \$670,295 to the Moscow Urban Renewal Agency FY2021 Budget.

The URA expects to complete the sale of 5 Alturas lots for a total of \$670,295 before the end of FY2021. The revenue will be receipted into Gain/Loss on Sale of Assets (890-000-478-10) and will flow through to Ending Fund Balance (890-000-990-00).

Repayment of the estimated proceeds of \$670,295 will be returned to the taxing district by the end of calendar year 2021.

MOSCOW URBAN RENEWAL AGENCY RESOLUTION NO. 2021-03

A RESOLUTION OF THE MOSCOW URBAN RENEWAL AGENCY, AUTHORIZING THE AMENDMENT OF THE ANNUAL BUDGET FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2020 AND ENDING SEPTEMBER 30, 2021 TO APPROPRIATE MONIES IN THE SUM OF TWO MILLION FIVE HUNDRED EIGHTY-FOUR THOUSAND TWO HUNDRED TWENTY-FIVE DOLLARS (\$2,584,225) FILING WITH THE LOCAL GOVERNING BODY, FOR INFORMATIONAL PURPOSES, PURSUANT TO IDAHO CODE 50-2006; AND PROVIDING THAT THIS RESOLUTION BE EFFECTIVE UPON ITS PASSAGE AND APPROVAL.

WHEREAS, the Moscow Urban Renewal Agency (Agency) was duly created pursuant to Idaho law by the Moscow City Council via Resolution 95-13; and

WHEREAS, the Agency is required to adopt an annual budget for filing with the local governing body, the City of Moscow; pursuant to Idaho Code 50-2006(3)(d); and

WHEREAS, the Agency is further required to comply with the open meetings law pursuant to Chapter 23, Title 67, Idaho Code, and as such set an annual budget hearing, noticed for August 19, 2021; and

WHEREAS, the Agency conducted a public hearing and approved budget Resolution 2021-02 on August 19, 2021; and

WHEREAS, the Agency has receipted unanticipated revenues through the sale of real property and hereby amends the annual budget for the fiscal year beginning October 1, 2020 and ending September 30, 2021.

NOW THEREFORE BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE MOSCOW URBAN RENEWAL AGENCY AS FOLLOWS:

Section 1: There is hereby appropriated out of any monies in the treasury of the Urban Renewal Agency of Latah County, City of Moscow, Idaho, not otherwise appropriated, and out of any revenue which said Urban Renewal Agency may acquire between the first day of October, 2020, and the thirtieth day of September, 2021, in the amount of two million, five hundred eighty-four thousand, two hundred twenty-five dollars (\$2,584,225) for the purpose of defraying all necessary expenses and liabilities of such agency for the fiscal year beginning the first day of October, 2020, and ending the thirtieth day of September, 2021.

Section 2: The following provides the total revenues, beginning fund balance, total resources, total expenditures, ending fund balance, and total budget for the Moscow Urban Renewal Agency for the fiscal year beginning the first day of October, 2020, and ending the thirtieth day of September, 2021:
