3. 2025 Strategic Plan Update (A) - Cody Riddle

In 2020, the Board adopted the current, five-year Strategic Plan that includes goals and objectives to guide the activities of the Agency. The plan will expire in the coming year and the community has evolved since its adoption. Staff will lead a discussion focused on the background, goals, objectives and strategies for an update to the plan.

Riddle started the discussion on the proposed Strategic Plan update with a conversation about the goals, objectives, and strategies. There is a comment submittal form on the Agency website where the public can engage with the Board and staff. There was a conversation about possibly updating the website to become more user friendly. There was a conversation about providing an explanation in the plan about how the Agency is funded and set tangible goals. The Board expressed interest in collaborating with the Moscow Planning and Zoning Commission.

Staff will draft the proposed updates based on the Boards conversation and bring it back for review at the next meeting. The Board continued to discuss possible updates to the Legacy Crossing District plans and objectives. There was a conversation regarding the Sixth & Jackson Street property in particular.
